- Call to order by Mayor Schindler at 7:00 PM
- Pledge of Allegiance led by Mayor Brent Schindler.

Roll Call by City Clerk- In attendance is: Aaron Hansen, Blaine Ball, Cody Green, Brent Schindler and Ryan Bonilla. Also in attendance is City attorney Bart Birch.

Action Items

Approval of III-A, health insurance agreement- Action

Amy from III-A Insurance presented a breakdown of the proposed III-A health benefit packages and contracts. Hansen asked about entering into an agreement with another entity and asked about the legality of it. Hansen moves to approve the city entering into the Joint Powers Agreement with IIIA. Ball seconds. Motion passed.

Adopt Preliminary FY2023 Budget- Action

Mayor Schindler asked about final budget numbers and if there was enough included in salaries to consider raises for current employee. Hansen stated that while he appreciates everything that the Clerk does he feels like adding health insurance was the next step in benefit plan without raises or cost of living adjustments. Adjustments were made to allow for more revenue for the water and sewer funds to anticipate more new utility connections which will be corrected later in the year with an amendment process.

Ball moves to adopt FY23 preliminary budget as presented. Green seconds. Motion passed.

Fee Schedule Update, Resolution #2022-03- Action

Fee schedule updates include a 4.99% fee increase to both water and sewer rates and went into effect July of 2022. Ball moves to approve resolution 2022-03. Green seconds. Motion passed.

Public Works Position- Action

Review was made on Tetonia's position with applicants and interest in the public works job. Council decided to offer a 90 day trial period for the applicant that offered to work 4 days a week including over a weekend. No motion needed.

- July Claims- Hansen moves to approve claims as presented, Ball seconds. Motion passed.
- <u>July Minutes-</u> Hansen moves to approve June minutes with the spelling and grammar edits and modifying the wording of the CUP motion. Green seconds. Motion passed.
