

### **AGENCY UPDATES:**

#### **Eastern Idaho Public Health (EIPH)**

1. EIPH has been providing guidance to business, schools, home health care, and others and has been providing Health Care providers with guidance and testing information.
2. There is still only one confirmed case of COVID-19 in Teton County. 

### **Teton Valley Health Care:**

1. Teton Valley Health is open for business with regular hours.
2. There is no delay on medical activities for in-patient or out-patient services.
3. We are testing patients who meet the criteria for testing. Please call 208-354-2383 if you have questions.

### **Teton County Fire & Rescue:**

1. Teton County Fire & Rescue is well trained and logistically prepared to respond to and support this type of infectious disease emergency. They have the resources and procedures in place to protect our personnel and deliver appropriate emergency services to our County and support the needs of our Community Partners as this unfolds.
2. Teton County Fire & Rescue is suspending business travel, multi-crew training, participation in community events and other nonessential external activities until further notice. This includes canceling station tours, engine tours, ride-alongs, and community training classes.
3. New temporary policies were implemented to prevent the unnecessary exposure of our firefighters and critical staff to the virus. Public access to the stations is now restricted, services will be provided via phone and email during normal business hours.

### **Teton County Sheriff's Office**

1. The Driver's License Department will suspend the following services until further notice:
  - Fingerprinting of first time concealed weapons license applicants – Renewals do not require fingerprints
  - Applicant fingerprinting services, including fingerprints for employment or background checks.
  - Renewals of Class D and other non-CDL licenses – These renewals can be obtained online at the Idaho DMV website.
  - Duplicates of lost/stolen licenses – Replacement licenses can also be obtained online through the Idaho DMV website.
2. Persons seeking to obtain their Idaho Star Card/Real ID are encouraged to wait for the time being to continue the application process.
3. Commercial Driver's License applicants will still be provided services.
4. If members of the public have questions about services, call the Sheriff's Office at (208) 354-2323 prior to coming to the Driver's License Office.
5. Signage will be posted at all public entry points advising individuals not to enter the Law Enforcement Center if they have: Visited China, Iran, South Korea, any European countries, or any other high risk locations identified by the CDC in the past 14 days; Resided with or been in close contact with someone who has been in any of those countries within the previous 14 days; Traveled domestically within the United States where COVID-19 has sustained widespread community transmission; Been asked to self-quarantine by any doctor, hospital or health agency; Been diagnosed with or have had contact with anyone who has been diagnosed with COVID-19; or A fever, cough or shortness of breath.

### **Teton County:**

1. In an effort to reduce the possible spread of the COVID-19 virus, Teton County is restricting public access to the courthouse (and other county facilities) for essential services only that cannot be completed remotely (via the County website, phone or email). 2. The Board of County Commissioners met today and decided not to declare a state of emergency but is prepared to do so at any time, if deemed necessary by the Board Chair and Emergency Manager..

### **City of Driggs:**

1. City Council held an emergency meeting today at 11:30 am to discuss the city COVID-19 response. No action was taken. The Council did not adopt an emergency declaration at this time. The city will continue to monitor the situation and will consider this action in the future as needed.
2. City operations continue, with staff being limited so as to provide for continuing operations capacity in the event of an outbreak.
3. The Public are encouraged to pay bills online at [DriggsIdaho.org](http://DriggsIdaho.org), or by using the dropbox in the parking lot north of the building (adjacent to Barrels & Bins). Walk-in traffic is discouraged. We request that you schedule appointments with staff and/or talk with them by phone.
4. All noticed city meetings have been continued (postponed) for a week as we seek functional and safe methods of conducting them in a responsible manner.
5. The City would like to emphasize that city water remains completely safe. There is no possibility of contamination of the city water supply.
