1. EIPH received the one pending test result today for the close contact of the positive case from Teton County. It was NEGATIVE!

- 1. TVH received two additional test results today (in addition to the EIPH notification) and both were negative
- 2. TVH has closed the See n Save Thrift Store, effective today, until further notice

#### **Teton County:**

1. The Teton County Board of County Commissioners will meet in an Emergency meeting tomorrow Friday March 20, 2020 at 10:00 am to consider an ordinance that would enforce restrictions on certain businesses and group gatherings of more than 10 people in response to the recently passed Emergency Declaration for COVID-19. 2. The County will begin limiting all public access to County facilities with the exception to the Courts and Transfer Station beginning Friday March 20, 2020. Details are forthcoming and will be posted on the County website and Facebook pages.

#### **City of Driggs**:

- 1. The City Council has extended the Emergency Declaration of the Mayor to require the following. See full text here. These regulations will be strictly enforced:
  - a. No gatherings of 10 or more unrelated people in the City of Driggs, including in any business, or other meeting place;
  - b. Restaurants in the City are required to close their dining rooms, and may only offer curbside take-out, no patrons allowed in restaurants (even waiting for food.)
  - c. No unpackaged self-serve food or beverages allowed;
  - d. Additional requirements apply, so see <u>Driggs City website</u> for more information.
  - e. Exemptions for Hospital and Health Care, Government Meetings, and School Food Distribution apply.
- 2. City Offices remain open by appointment only. (Please call ahead to schedule, or use online methods.) All public meetings have been continued (postponed) until we can set up safe and functional remote meeting options.
- 3. All group events at Driggs Community Center have been cancelled or postponed, but the building remains open during business hours. TISA, Seniors, Rock Gym, and GeoCenter have all closed or limited access to their facilities. Please contact them directly if you have any questions.
- 4. Driggs Reed Memorial Airport remains open for aviation access only at this time.
- 5. Driggs City Parks remain open per normal hours. We encourage people to get outside, and move their bodies just avoid groups. Be advised that, although our restrooms are being cleaned, playgrounds are not receiving any special attention at this time.
- 6. The City would like to emphasize that city water remains completely safe. There is no possibility of contamination of the city water supply.
- 7. Please do not flush anything down toilets except toilet paper!

## **City of Victor:**

- 1. On March 18, 2020, Chair Riegel, Mayor Frohlich, Mayor Johnson, and Mayor Hoopes signed a Joint Emergency Declaration for Teton County, Idaho and the Cities of Tetonia, Driggs, and Victor. The Victor City Council subsequently extended the declaration through April 30, 2020 on behalf of the Victor community.
- 2. In direct response to the COVID-19 pandemic, on March 19, 2020, the Victor City Council unanimously passed an Emergency Ordinance to limit gatherings of 10 or more people, to restrict dining-in at restaurants, and to close self-serve food offerings and certain types of facilities to protect the health, safety, and welfare of the Victor community. The principal provisions of the Ordinance are as follows:
  - a. Gatherings of 10 people or more are prohibited except for within businesses and the hospital. All businesses that remain open must accommodate all employees and patrons with at least six (6) feet of separation from one another. Hospitals and health clinics, school district food services, and government buildings while conducting public meetings are exempt from this requirement.
  - b. Restaurants may provide curbside take out or drive thru food service only provided certain precautionary procedures are followed as listed in the Ordinance.
  - c. The following facilities are hereby closed: All theaters (film or stage); Bars, Nightclubs/Saloons/Taverns or Tasting Rooms; All coffee/tea shops, except for drive-through, or take-out service; Self-serve or staff-served buffets or Salad bars; Unpackaged self-serve food services; All communal pools, hot tubs, locker rooms, saunas, steam rooms, fitness centers, gyms, conference rooms, and spas; All museums.

- d. This Ordinance is effective through April 30, 2020 but it will be repealed sooner should circumstances warrant.

- 4. Utility bills may also be mailed to the City at PO Box 122, Victor ID 83455 or placed in the drop box at City Hall. 3.
- 5. The March 25, 2020 City Council meetings have been cancelled.
- 6. The water supply is safe and is not compromised as a result of COVID-19. 5. Please do not flush wipes, paper towels, or any paper products other than toilet paper.

# **City of Tetonia:**

- 1. At this time Tetonia has decided that all of our businesses are voluntarily following recommendations by Governor Little or are staying open for essential services. Therefore, Tetonia City Council did not see a need to create an ordinance at this time. We will continue to monitor daily and reevaluate as needed.
- 2. Tetonia City Hall may have limited office hours over the following weeks. Residents are encouraged to take advantage of the payment drop box and online bill pay. Public Works will continue to operate normal hours. This may change as circumstances progress.
- 3. Please do not flush wipes, paper towels, or any other paper products other than toilet paper.
- 4. The City of Tetonia water supply is clean and safe and will remain clean and safe.

# **Teton School District 401:**

- 1. The Board of Trustees is holding a special meeting tonight at 6 pm to hear updates on COVID-19. The meeting will be livestreamed on the district's Facebook page; most board members will be calling in to attend rather than being there in person. Public comment is not included on the agenda, and will not be taken.
- 2. TSD 401 is now serving free meals to anyone aged 1-18 at three locations: the new Driggs Elementary, the new Victor Elementary, and Tetonia Elementary. This is an updated link to include all three sites and meals every day from Friday, March 20 Friday, March 27. Free meals will not be made available during Spring Break.

In order for Idaho and our region to become eligible for assistance, affected Idaho businesses need to file an Economic Injury Worksheet. In our state, this effort is being led by the Idaho Department of Commerce. businesses. Even if you do not plan to apply for financial assistance, completing and submitting the form is helpful in assisting other Eastern Idaho businesses who may apply.
