Action Items

TVBSA Park Reservation Cost- Action

Bonilla abstains. In the past years, the park fee for the Teton Valley Baseball Softball Association has been \$425.00. Conversation was made around keeping the same yearly cost as well as some in kind donations of mowing the park or other park maintenance and/or repairs from the association. Hansen moves to keep the yearly cost of \$425 as well as payments of in kind of mowing. Ball seconds. Motion passed.

Building Permit Issued Timeline- Action

Tetonia Building inspector suggested that Tetonia extend building permit timelines to a 2 year permit rather than the current 1 year. Currently Tetonia building permits are issued for a period of 1 year with a \$100/per year option for extension. City Council discussed other cities and county permitting. Final decision was not to change permit time frame and to stay at 1 year permits. No motion needed.

Electrical Update Quote- Action

Utility Winter Overage- Action

Council discussed a few resident account who ran excessive water through winter months. Decision was to not wave any fees and to bill as usual.
